The Sexual Assault Advocacy Associate will primarily complete strategic planning and activities for Oakwood Haven as it pertains to Sexual Assault awareness within the community.

- Associate's degree in a related field or two (2) years equivalent of education and experience with proven effectiveness.
- Pass a criminal background check.
- Pass a Drug Screening Test.
- Possess a valid Wisconsin Driver's License and automobile insurance.
- Deep familiarity working with various social media platforms.
- Understanding of Trauma Informed Care.
- Excellent computer and technological skills.
- Good understanding and demonstrated skills regarding domestic abuse and sexual assault.
- Outstanding oral and written skills.
- Ability to communicate effectively, problem-solve and work well with people from diverse backgrounds.
- Must be able to work independently with limited direction and meet deadlines.
- Must be able to maintain and handle sensitive confidential material.
- Must be organized, detail-oriented and flexible.

 education should promote survivor safety and self-sufficiency
- Provide strategic planning that will help survivors transition to virtual/remote services for Sexual Assault care providers in the event of a crisis that leaves us unable to fulfill in-person services.
